SEPTEMBER 25, 2017

The NCCU Board of Trustees held a Board of Trustees Orientation/Retreat on Monday, September 25, 2017, at noon at The Friday Center, 100 Friday Center Drive, Chapel Hill, N.C.

Chairman Hamilton welcomed all attendees and introduced the new NCCU Board of Trustees-Elect namely:

- John Alexander Herrera, a native of Costa Rica, graduated from the University of Delaware in 1992 and began his career at the World Wildlife Fund in Washington, D.C. Herrera earned a master's degree from North Carolina State University and joined Self-Help Credit Union as senior vice president for Latino/Hispanic Affairs in 1999. He was a founding member of the National Association for Latino Community Asset Builders. Appointed by the University of North Carolina (UNC) Board of Governors, his term expires June 30, 2021.
- **Kevin M. Holloway**, a 1975 business administration and finance graduate of NCCU, served as vice president for the U.S. supply chain at Monsanto Agrochemical Co. before founding his own company, Holloway Executive Consulting, in 2014. Holloway is a member of the NCCU Athletic Hall of Fame as a major contributor and has served on the Board of Visitors for the NCCU School of Business. Appointed by the UNC Board of Governors, his term expires June 30, 2021.
- **James S. Walker**, a 1988 summa cum laude graduate of the NCCU School of Law, was a practicing attorney until 2000, when he became certified by the N.C. Dispute Resolution Commission as a Superior Court mediator. He is currently self-employed as a mediator.

A Charlotte, N.C., native, he also serves as a member of the N.C. Turnpike Authority Board. Appointed by the speaker of the N.C. House of Representatives, his term expires June 30, 2021.

- **Isaiah Tidwell**, a 1967 Eagle graduate, was named by the UNC Board of Governors to fulfill the unexpired term of Darrell T. Allison, who now serves as a member of the UNC Board of Governors. Tidwell worked at Wachovia Bank for 35 years and was executive vice president and director of wealth management for Georgia before retiring in 2005. He received the Distinguished Alumnus Award from NCCU in 2001. His term will expire on June 30, 2019.
- Michael Hopkins, was elected NCCU Student Body President in April 2017. He is a senior majoring in pharmaceutical science with a minor in biology and chemistry. He grew up in Raleigh and attended Leesville Road High School where he played football, basketball and ran track.

This summer he was an intern at Harvard Medical School studying neuronal mechanisms that affect motivation and plans to attend medical school after graduation.

Next, Chairman Hamilton introduced the guest speaker Attorney Artis Hampshire-Cowan, a consultant/senior fellow at the Association of Governing Boards and a former Senior Vice President and Secretary of the Board at Howard University. ☐ Maintain a tradition of exemplifying the highest standards of ethical behavior;
☐ Support the role of the Chancellor as chief executive officer when she is
carrying out delegated authority for all academic, administrative, fiscal and
personnel matters;
☐ Maintain the confidentiality of matters not public;

 □ Attendance – 100% is desired, but if conflicts occur, please communicate in advance; □ Stewardship – make a financial gift that is significant and a significant introduction;
☐ Be aware of challenges and opportunities facing higher education;
☐ Always be aware of your audience;
☐ Knowing you are accountable for your actions;
☐ Be respectful of each other – ways to engage without attacks.
Chairman Hamilton reminded the Trustees that at the Committee Meeting on Tuesday, September 26 th at 8:30 a.m., on the campus of North Carolina Central University, Trustees-Elect will be sworn in.
